3. HAZARDS IDENTIFICATION

Irritating to eyes and Skin

Eye contact: Will cause dryness and irritation

4. FIRST AID MEASURES

5. FIRE FIGHTING MEASURES

6. ACCIDENTAL RELEASE MEASURES

Do not allow neat product to soak into drains or water courses. Soak liquid in absorbent material and collect in a container. No further special considerations.
